The meeting took place at the QTH of K4DMA an March 13, 1975. The following items were discussed:

- NKARC received corporation papers from

the state of Kentucky.

- K4DMA talked with the Red Cross about a future meeting place, since the Covington Red Cross building has been sold. Club equipment will be moved from the building on Saturday, March 15 at 10 a.m.

- Insurance coverage for equipment in the club trailer will be obtained at this time (as discussed at past club meetings). - The proceedure of allocating club funds was discussed. The following was decided:
- 1) officers will allocate a specified amount for needed items; the club votes on the allocation at the general meeting, and then we shop for the best price.

2) all purchases must be approved by the officers. Up to \$50 can be approved by the officers alone. Over \$50 must be voted upon by club members after being presented by the officers.

- There was discussion of having a dinner (wives included), followed by a short business meeting and a program - for a

future Tuesday meeting.

- WA4KUB will furnish a door prize for the next meeting - a gold pen and pencil set by Cross. Must be present to win. This idea may be continued at future meetings.

# MARCH MEETING (March 4, 1975)

The meeting was called to order by President Bob Pentz, K4DMA, at 8:05 pm. The minutes of the previous meeting were approved as read.

A short report on the American Cancer Orive to be held April 29 was given. More details will be available later. Neal Mays WB4WSG, and Dave Heil, WB4KTR, will be in charge of the drive.

The Red Cross will be moving by March 20. Club equipment must be moved from the

building by that time.

Roger Schmitt, WB4H DW, gave the reasurers report: total of \$1,227.58.

WA4KUB, Dick Johnston, reported that two letters of acceptance were received from prospective Ham-O-Rama forum speakers.

John Robinson, a weather forecaster for the U.S. Weather Bureau, gave a program (with a film) on what to watch for luring a severe weather watch, etc.

# KYN EMERGENCY

At about 9:35 p.m. EDT Joe Rice, W4RHZ, called Dave Nelson, WB4WND, by telephone and advised him that there might be a serious disaster at Henderson and Centertown, Ky. W4RHZ received traffic from W4YOK to this extent earlier during the regular KYN session that night. Both immediately got on 3.60 mhz and decided to

call a KYN emergency session.

WB4VND acted as NCS and sent the first call-up at O145Z. K4CNY checked in from Tennessee with traffic for LVL. W4YOK then checked in and advised WB4WND that there was no damage in Henderson, but there was extensive damage in Centertown. At this time VB4VND sent a QNC from W4RHZ giving the basic information about the situation in Centertown. W4YOK then reported that W4TOY/4 was on the scene and that they were in contact via 2 meter fm. W4TOY/4 advised NCS that there was at least one phone operating in Centertown it was (502) 232-5136.

A few minutes later, W4YOK reported that everything was under control at Centertown and there would be no need for KYN for the next few hours. WB4WND sent a QNC message to this effect and called off the KYN alert. The net was closed at

After closing the net, WB4WND called the Cincinnati Red Cross and gave them .all the information, including the working phone number at Centertown.

(Most of the activity was centered about 200 miles south-west of Covington

in Henderson County.)

# FCC RESTRUCTURING

The word is out! And in case you haven't heard about it, the FCC docket # 20282 says it all. It splits amateur licensing into two segments: operation either below or above 29 mhz. Two new classes of licenses will be introduced, and existing ones changed considerably.

A complete presentation was given at the February NKARC meeting. Here is a re-cap of how you'll be effected - if it

goes into effect:

- Amateur Extra Class: Retains all privileges but would have to share exclusive voice segments with Advanced. Lifetime operator license. New power limit of 2 kw pep output.

- Advanced Class: Converts to same class and also new Experimenter grade. Retain all privileges plus gain use of present exclusive Extra voice bands, and

the 2 kw pep output limit.

- General Class: Converts to same class and also Technician grade. Will lose use of 29.0 - 29.7 mhz, and be limited to Al, A3, and F3 emmissions. New power limit

of 500 watts pep output.

- Technician Class: Any present licenses attained by mail exam will not be renewable. Technician FCC-supervised exam licensees could renew. All would be granted (on application) all Novice privileges also. Technicians would be permitted 500 watts pep output with only Al, A3, and 3 emmissions where authorized in all ands above 50 mhz (would gain 50.0 - 50.1 and 144-145 mhz).

- Novice Class: Becomes a 5 year enewable license. Application fee will be equired. Same privileges except a new

250 watt input limit.

ermit Mr. 1850 \*Tower Ladder Problem: A note from the U.S. Department of Labor states that ladders will not be required on radio towers used for personal application. The new rules apply only to towers which will be climbed by employees. This could be interpreted as applying to amateur towers where someone is paid to climb it. The rules are not final yet.

\*CB Linears: Now that the sale of CB linears has been prohibited ... and the possession of them by CBers made illegal, ... a question arose about whether amateurs could buy and sell them. The FCC says yes, you can sell a 10 mtr amplifier as long as yyou sell it to another licensed amateur - and you'd better get his signature and call sign on your receipt.
