NKARC GOES VHF

"That's an unusual call...Never heard a two-letter K4 call before...What a call for a contest..." These were just a few of the many favorable comments heard by operators using the K4CO call on June 14 and 15.

A group of NKARC members made 200+ contacts on six meter ssb and two meter fm during the VHF contest two weeks ago. Using the club call, 32 ARRL sections were worked on six meters. This helped boost the total contest score to a

respectable 7070 points.

Uncertainty plagued the operation to within 24 hours of the contest starting time. The QTH of Bill Martin, K4JBV, (Independence, Ky) was used for the event. First, the six meter linear had to be repaired. Then the rotor atop 'JBVs 70 foot tower had to be replaced.

All participants are already looking forward to the next contest.

CLUB JOINS ARRL

The NKARC has submitted it's application for ARRL affiliation. Response to our application was received in late May. We are now waiting on approval by the ARRL Executive Committee.

With two years of experience and a 2-letter call, this should be 'the year'. Antennas will consist of a three element tri-band beam, a three element 15 mtr beam, a verticle on 40 mtr, and six elements on 6 mtr. Equipment will consist, in part, of the Drake T-4B, R-4B for low bands, and a TR-6 for 6 mtr.

How to keep plenty of activity on 146.58? That's the unanswerable questionor is it! With the invention of two meter repeaters, many amateurs are monitoring them constantly - and leaving their simplex x-tals for the spiders. 146.58 still has plenty of activity. Let's keep it that way, since it's the club net frequency.

There are two alternatives for those that want both repeaters and .58: 1) a beeper (two 'dits' would be sufficient) on the local repeaters (only three in northern Ky) every time someone puts a carrier on .58; or 2) a scanner installed in each person's two meter rig.

Thus, amateurs could monitor the repeater (with greater coverage), but will still know when there's activity on .58 mhz.
