The basic fee for a new, renewed, or modified-renewed amateur license drops March 1 from the present \$9 to a new rate of \$1; straight modifications drop to \$3, and duplicate licenses to \$2.

Novice, RACES, and military recreation authorizations remain free. Special calls remain at \$25 in addition to other fees which may be due.

#### CLUB MEMBERS GUESTS OF N. KY. POLICE ASSOCIATION

Two members of the Northern Kentuck Amateur Radio Club, President Bob Penta, KhDMA and Gary Johnston, WBhFAT, were invited guests of the Northern Kentucky Police Association's monthly breakfast meeting held at the Newport Travel Lodge February 18. The group represented Police Officials from Kenton and Campbell Courties, members of the FBI and the honorable Mayor Vories from the City of Newpolohn Robinson, from the U.S. Weather Bureau, Greater Cincinnati Airport, was also an invited guest speaker.

Gary Johnston was introduced to the membership by Paul Flaugher, W8VEL, a retired Hamilton County Police Captain, and now employed in the Hamilton County Regional Crime Information Center.

Gary gave a brief informative account of the NKARC emergency communication net-work, and invited the local police force to utilize this service in time of disaster. It was a real opportunity for NKARC to illustrate it's effectiveness through actual demonstratiusing Gary's mobile 2 meter equipment fo phone patch and direct communications with Bill Martin, KhJBV, mobile in Northern Kentucky.

Bob Pentz summed up the demonstrativith brief comments relating to NKARC affiliation with the RED CROSS, and related the recent training program with the local chapter. NKARC Emergency Communication Facilities were again offered to all in attendance. Appreciation was expressed for the cordial invitation to attend and participate in the breakfameeting.
